### Recommendation to Council – Recreational Trails Management Plan

                  That the Community Development Committee recommends changing paragraph 2.6 Hunting in the Management Plan to now read “Hunting on Crown property is regulated by the Ministry of Natural Resources under the *Fish and Wildlife Conservation Act*. Recognizing the area as traditional hunting territory for local residents, restricted use along the trails will be enforced by the Municipality during Resident and Non-resident Open Season for moose and deer. The dates to determine these seasons are set by the Ministry of Natural Resources from year to year and therefore will be posted at all entrances to the Whitestone Lake Trail and the Clear Lake Trail on an annual basis. Use of the trails will be restricted to individuals properly licensed by the Ministry of Natural Resources. Other users wanting access to the trails during the restricted time may request special permission from the Municipality”. **Carried**
